# 2019 POLICIES

FORBIDDEN TAKES PRIDE IN BEING AN INCLUSIVE EVENT FOR PROGRESSIVE, OPEN-MINDED ADULTS.
THE OVERRIDING PRINCIPLES FOR THE EVENT ARE COMMON SENSE, RESPECT FOR OTHERS,
SAFETY. AND REASONABLE BEHAVIOUR.

#### **RESPONSIBILITIES**

- All attendees will sign a waiver prior to being admitted into the event and show proof of valid government issued ID. Health cards can be accepted with the sign of a release as per ministry guidelines.
- A signature of acknowledgement will indicate that the rules have been read, are fully understood, and are agreed to by the attendee.
- The attendee is responsible for knowing the rules and the privacy expectations of the event.
- The attendee is responsible for immediately notifying Event Staff if they are having a problem with anyone, or notice someone disregarding the rules that could put a person or the event in jeopardy.

#### **IDENTIFICATION**

- All registered guests must present proof of registration and valid photo ID to enter the event.
- Attendee wrist band identification must be worn at all times and be completely visible.
- Missing or damaged wristbands must be replaced immediately, and this is the responsibility of the attendee. Government photo ID will be required when wristbands are replaced.
- Replacement wrist bands will be at the attendee's expense.
- Attendees found to have transferred their identification and/or impersonating another registered guest will be immediately evicted from the event without refund or remuneration and/or banned from future events.

#### THE POINT RULES

- The POINT Tent and Trailer Resort Rules and Policies are also in effect and are not superseded by the rules of this event;
   with the exception of the members only designation.
- All attendees must review and abide by the general park rules prior to participating in this event.

#### **MANAGEMENT**

- Management reserves the right to amend these rules without notice or publication.
- Management reserves the right to evict any attendee from the event without explanation and without refund or remuneration.
- Management reserves the right to permanently bar an attendee from the event and future events without prejudice, explanation and without refund or remuneration.

#### **EVENT STAFF**

- Event Staff are here to ensure your enjoyment, and your full cooperation with Event Staff requests is expected.
- If you have any issues pertaining to the event, please notify the Event Staff or the Park Office.
- Failure to cooperate with Event Staff may result in eviction from the event without refund or remuneration.
- There shall be no disparaging, harassing or yelling at any employee or volunteer of the park. Violators will be permanently banned from the event and future events without explanation, refund or remuneration.

#### CONFIDENTIALITY

• Confidentiality is of the utmost importance to the organizers and attendees of this event.

- Any details with regards to persons in attendance, activities viewed, conversations heard, or information gathered at this
  event are to remain confidential.
- Persons in violation of this may be evicted from the event and/or future events.
- Where applicable, legal action may result.

#### **CHECK-IN AND CHECK-OUT**

- Everyone entering the park must register before entering the park.
- Check-in time is after 2:00 p.m. Early entry is at the park's discretion and availability.
- Check-out time is before 11:00 am and all attendees must have exited the park by this time. Please consult with the office prior to 10:00 am to extend your stay when permitted. There are no refunds for early checkout.
- Ensure your site is clean before you leave. A minimum site cleanup fee of \$150.00 will be charged to any guest(s) leaving a mess or damage to the site. This includes, but is not limited to, posts, picnic tables, fire rings, lawn, trees, garbage, unkempt fire pit, pet mess or damage, etc.

### **PUBLIC AREAS/SPACES AND OUTDOOR PLAY**

- Sexual activity and/or scenes in common areas is strictly prohibited. Common areas are defined as, but not limited to,
  washrooms and the areas around them, food venue, park buildings/office, Rec Hall and the pool and surrounding area,
  roads, Cloris meadow and the volleyball court, etc. Discretion is expected in other areas of the park partially during daylight
  hours. Be a good neighbour and consider all others around you and your location in the park.
- Please follow the rules, and show consideration for others and discretion when choosing a location.
- Management and Event Staff reserve the right to terminate any activity at any time if the location is deemed inappropriate.
- Please see CONDUCT & SAFETY in the park rules.

#### PUBLIC VS. PRIVATE SPACES FOR PLAY, ESPECIALLY INCLUDING OVERT SEXUAL ACTIVITIES

- All scenes and sexual play are prohibited in all public spaces specifically the pool, rec hall, office, bathrooms, public roads and walkways, Cloris meadow, volleyball court behind pool, overflow parking area, etc.
- What you do on your own site (or any site where you've been invited) is up to you, as long as it is still within the rules of the event and venue.
- The woods are technically public space, but scening and sex are permitted in the woods. This does NOT apply to the
  wooded areas on the edge of the campground down near the overflow parking. Those trees are very close to public
  walkways, so please DO NOT play down there.
- The bonfire pit is another area that is technically public, but during Forbidden, you can use this space for scenes and/or sex, etc. This space would be wonderful for people who want to play outdoors, but might want a bit more privacy.
- Exception to these rules are in effect when the area or space is being used for a public event or gathering.

# PROPERTY DAMAGE (TO THE GROUNDS, BUILDINGS, CABINS, ETC.)

- Attendees will be held personally responsible for any damage they cause or participate in.
- Do not attach, tie or fasten anything or anyone to any fixtures, including but not limited to pillars, rafters, pipes, etc.
- Please be mindful that your play does not cause damage to your surroundings, including picnic tables, fire rings, campsites, etc.

# **TECHNOLOGY (MOBILE PHONES, CAMERAS, DRONES, ETC.)**

- All recording devices are prohibited on the grounds with the following exception(s):
  - Recording devices include, but are not limited to, mobile phones and cameras and drones.
  - o Recording device usage is strictly limited to your allotted campsite, directed ONLY into your site and with the express permission of EACH person present.
  - Management may designate certain events as 'Photography Allowed' and the venues and times will be announced.
  - Violators may have their devices confiscated and recordings destroyed without remuneration.
  - Violators may also be evicted without refund or remuneration.

# **VENDORS/VENDING**

- All vendors must be approved by Management.
- Vending is only permitted from an attendee's site and/or at the Vendor Fair the park hosts.
- Unauthorized vending may result in being evicted without refund or remuneration.

# PROMOTIONAL MATERIALS (FLYERS, POSTERS, ETC.)

- All promotional materials must be approved by Management.
- Unauthorized materials will be removed and destroyed without notice or compensation.
- The unauthorized distribution of promotional materials may result in eviction without refund or remuneration.

#### **EMERGENCIES**

- Please familiarize yourself with the EMERGENCY PROCEDURE DOCUMENT located in the Park Office, Rec Hall and North Washroom.
- In the event of an emergency, please remain clear of the area so that the appropriate emergency personnel and /or Event Staff may do their jobs unobstructed.
- Unless you are directly involved, you are to vacate the area and maintain the confidentiality of those involved.
- Please respect the privacy and dignity of the person(s) involved.
- Management and Event Staff will communicate with emergency personnel and attendees when appropriate.

# R.A.C.K. (RISK-AWARE CONSENSUAL KINK)

- This event recognizes the acronym RACK
  - Risk-Aware > All participants take personal responsibility to be well-informed of the risks involved in the proposed activity.
  - Consensual > In light of those risks, all participants have, of sound mind, offered preliminary consent to engage in said activity.
  - Kink > Said activity can be classified as alternative sex.
- Management and Event Staff may terminate a scene, at their discretion, at any time without explanation or prejudice. It is
  understood that as an attendee at this event, you acknowledge and agree to comply with this decision without hesitation.
- As an attendee of this event you are responsible to ensure that any scene or play you are involved in has a Support Plan (not limited to emotional, physical, mental) in the event a scene or play is disrupted or terminated.
- In certain situations, rope, bondage equipment, etc. may have to be cut or quickly undone.
- Management and Event Staff are not responsible for replacing or making compensation, in any way, for the equipment in question.
- Your co-operation is vital to preventing these types of situations.

#### **ETIQUETTE AND EQUIPMENT USAGE**

- Please be polite and maintain a reasonable distance from scenes that you are not involved in.
- Please request permission to observe a scene that you are not involved in and refrain from talking and other distracting behaviours .
- If you are asked to move farther away from a scene, to be quieter, or to limit a distracting behaviour, do so immediately and respectfully.
- Please provide a wide berth around play spaces in order to prevent injury to the participant(s) or observer(s) and to allow for scenes to progress without interruption by audience speech.
- Once a scene is in progress, do not interrupt the participant(s) or attempt to participate without having negotiated your involvement prior to commencement of the scene.
- While engaging in a scene, participants are not to be left unattended at any time.
- Do not touch other people or their personal belongings without their express permission.
- Please be considerate of other attendees in terms of the amount of time you spend on a piece of equipment in the Play Tent.
- Attendees are prohibited from moving equipment in the Play Tent. If an attendee would like something moved, please ask the Event Staff.

- Please take care when using the Play Tent equipment that has been kindly donated for use during the event.
- The equipment must be cleaned immediately after a scene using the disinfectant products supplied.
- Use of the Play Tent and the equipment therein are at the user's own risk.
- Participants are responsible for their own safety when using the equipment provided.
- Drop cloths are required for play involving bodily fluids, wax play, food play, and any other activities that may result in a
  mess of any kind.
- Attendees are expected to clean up after themselves and remove all personal belongings, garbage, etc. and put in their proper place/dispose of safely.
- Play Tent equipment and other fixtures should be left free of sweat, bodily fluids, lubricants, etc.
- Play Spaces/Areas should be left in the same, if not better, condition than when play commenced.
- Attendees participating in bondage scenes must have safety shears or some other appropriate cutting device within immediate reach.
- Scenes involving or resulting in surface or airborne contact or contamination with bodily fluids are prohibited in communal spaces on the grounds.
- Please do NOT cut through people's sites or cut diagonally across corner sites, even if no one is on the site at the time, or the site looks empty. It's someone's home for this event, so please stick to the footpaths.

#### **SAFE WORDS**

- The event safe word for STOP is RED; the event safe word for CAUTION is YELLOW.
- Loudly shouting one of these safe words will be interpreted as a call for outside assistance.

# EDGE PLAY (BLOOD PLAY, BREATH PLAY, CUTTING, ETC.)

- Edge Play is PROHIBITED in Public Areas/Spaces and the Play Tent.
- This type of play must utilize appropriate barriers and precautions to protect attendees, Event Staff, equipment, and fixtures from surface or airborne contact or contamination with bodily fluids (i.e. blood, ejaculate, etc.)
- Attendees are responsible for the proper disposal of sharps.
- Attendees are responsible for providing their own supplies if they wish to engage in this kind of play.
- Participants are expected to thoroughly clean up after this kind of play.
- Knives, swords, and other cutting instruments must be sheathed or contained at all times when not in use for a scene.
- Breath Play must not block the intake of air for more than 30 seconds.

#### **FIRE PLAY**

- All fire play must be pre-approved with event staff.
- Fire Play is prohibited during a Fire Ban.
- Participants must always have a fire extinguisher, drop blanket and medical supplies present and immediately available during this type of play.
- These rules apply to fire play/cupping, fire poi/spinning, wax play with open flames.

#### PROHIBITED SCENES

Any situation or play that endangers an attendee's life is prohibited. This includes, but is not limited to, water boarding,
drowning scenes, fire walking/walking on coals and lengthy breath control, percussion play on open wounds, etc. If you are
unsure of a scene or type of play, contact Event Staff for approval prior to initiating.

#### **SAFER SEX**

• Attendees are strongly encouraged to practice safer sex; supplies are available in designated area(s), which include the park store, the Rec Hall, the Play Tent, the wooded play area.

#### **SOLICITATION**

- Prostitution, solicitation and negotiation of payment for sexual services is strictly prohibited.
- Violators will be ejected from the event without refund or remuneration.

# TAKEDOWN/ABDUCTION SCENES CREW(S)

• This type of scene NEEDS prior approval. You must review the plan with Park Management when, where and how the takedown will be taking place so that camp staff are aware of the plans. This is to be done by email before and/or at camp.

#### FEDERAL AND PROVINCIAL LAWS

• Attendees are to obey all federal and provincial laws and ordinances.

#### SUBJECT TO CHANGE CLAUSE

The rules and policies of The POINT Tent & Trailer Resort are subject to change without notice.

# **Indemnification and Liability**

Attendees acknowledge that this is a campground and, as such, recognize that there are inherent dangers such as tree roots, rocks and other hazards that could cause tripping or falling. Attendees shall indemnify and hold harmless The POINT Tent & Trailer Resort and its owners and agents from and against any loss, damage, injury, claim, cost and expense (including legal expense at all court levels) arising out of or connected with their use of The POINT Tent & Trailer Resort. It is expressly agreed that all personal property or equipment now or hereafter placed, stored or located on the premises shall be the sole responsibility and at the sole risk of attendees and any damage, loss, theft, or destruction thereof shall be borne by attendees and shall be their sole responsibility.

Violation of any of the above policies will result in expulsion at any time from the property, revocation of the licensing agreement without refund, denial of future reservations privileges, and possible criminal prosecution.
